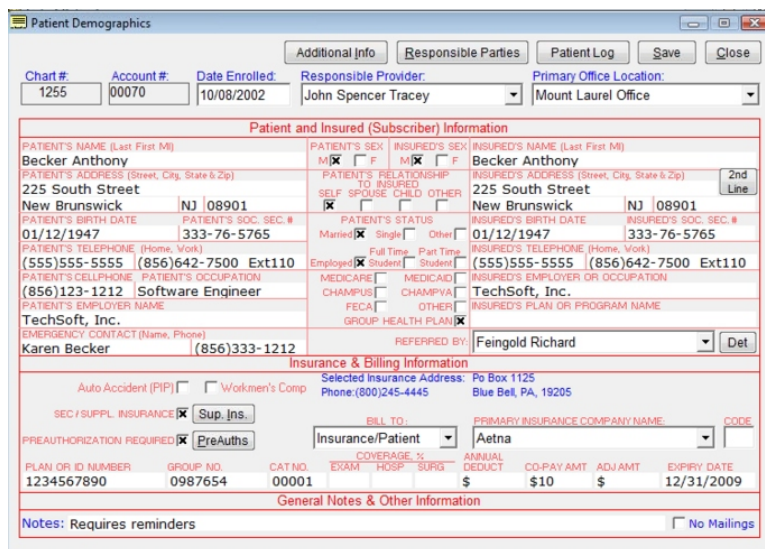

Patient Record Keeping

- Figure 2, Shows the patient registration screen laid out in the familiar, graphical CMS 1500 format.
- On screen buttons, check boxes, and drop down lists make entering and editing information fast and easy.
- Single data entry required, no repetition's.
- Critical Patient information is visible on a single screen, thus avoiding the time consuming task of memorizing related information on different screens.

- As shown above, the Patient Registration Screen contains each patient's demographic information, the patient's responsible provider, insurance company, and billing information.
- The patient's primary insurance company is displayed, along with plan number, group number, coverage, annual deductions, co-payments, expiration date, etc.
- Multiple preauthorization as well as pre-certification numbers can be added and maintained for automatic assignment at the time of billing.
- In addition to Primary, workmen's compensation, and auto insurances, up to two supplementary insurance carriers can be selected for each patient. In order to reduce data entry time, commonly used information is presented in alphabetical lists (like insurance company names, referring provider names, etc.).

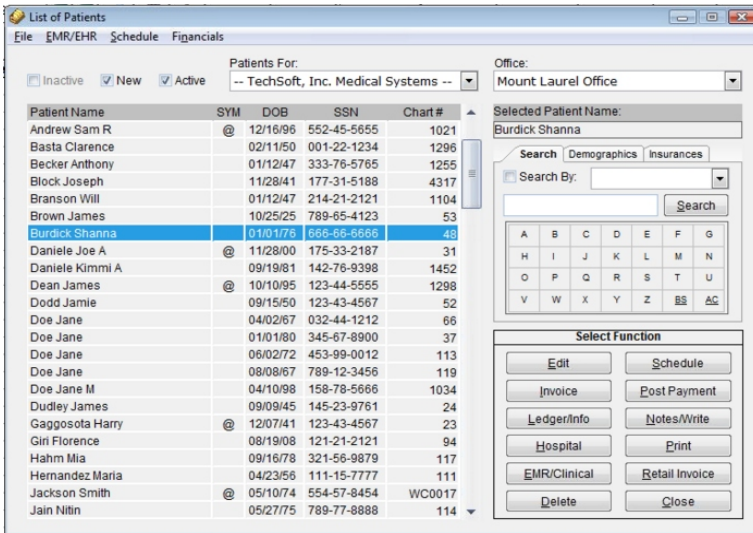


Figure 3 - Patient List Screen

- MDRhythm allows the user instant access to all patient records at the click of a mouse. The patient names are displayed in an alphabetic order with quick search feature to locate the proper name instantly (Figure 3). Patients can be searched by Name, Chart Number, Social Security Number, Date of Birth, Insured's Name, Primary insurance ID Number or EMC ID Number.



Paper and Electronic Billing/Invoicing

- Primary and supplementary billing in MDRhythm is very user friendly and highly productive. All billing information
- can be entered easily on a graphical screen with the important information quickly retrievable from lists.
- As per previous billing, default values are presented to save considerable amounts of time. In fact an entire invoice can be generated without touching the keyboard.
- A complete check of missing or contradictory information is performed and the user is notified of any inconsistencies by means of on screen message boxes. This minimizes the error rate and results in quick payments.
- Invoices can be printed on one of several form types, including HCFA 1500, UB92, Superbill, Cash Invoice, or any custom forms the user creates using the form setup screen. These forms can also be generated on plain paper using a laser jet printer.
- Electronic billing is extremely simple and involves clicking just one button. The user can display all the information about the invoice to be transmitted before initiating the electronic filing.
- This software comes complete with a listing of the current code numbers and descriptions for ICD-9-

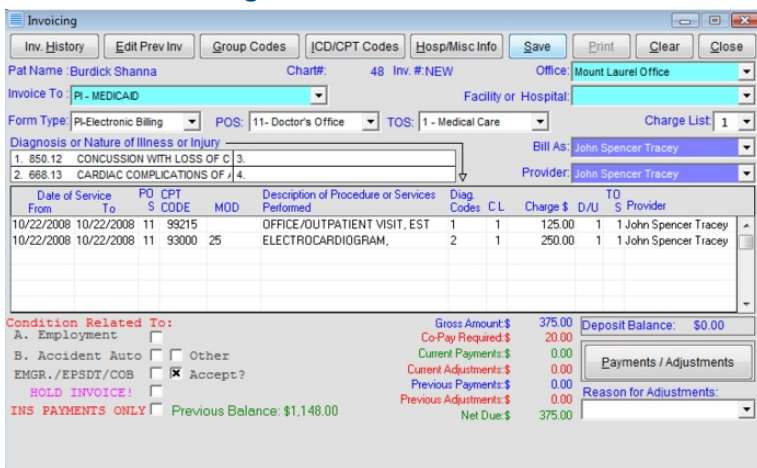
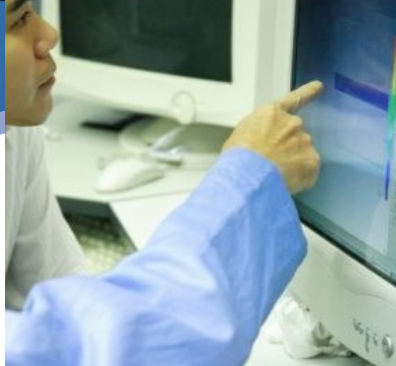


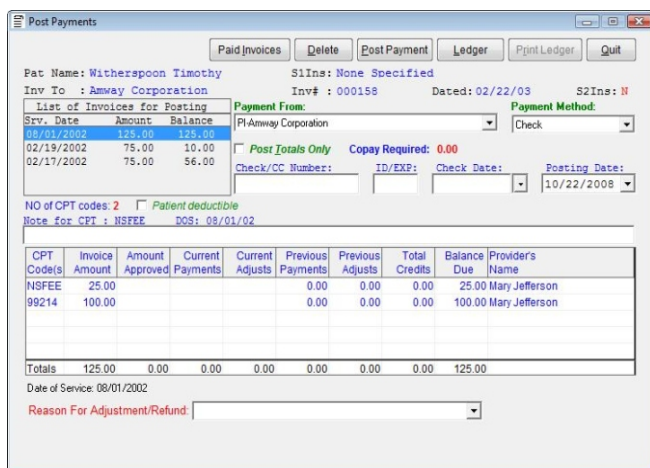
Figure 4 - Main Billing Screen

CM and the CPT-4 codes. Therefore, custom lists consisting of commonly used codes for each type of practice can be developed very quickly.

- Up to four charges can be assigned to each procedure code to allow automatic posting of charges for each procedure for different type of insurance carriers. The following picture (Figure 4) shows the main billing screen of this software.
- Co-payment requirements are displayed automatically to ensure proper collection from the patients. Any payments and/or adjustments at the time of invoicing can also be entered on the same color coded easy to read screen. For repeat visits, the previous invoice data can be imported to generate a complete current invoice in a fraction of a second.

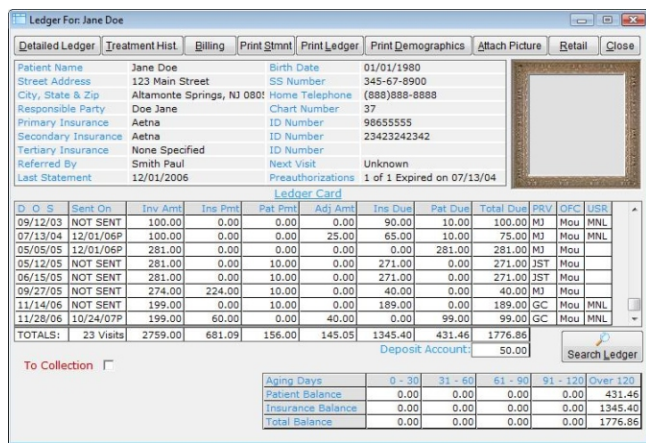

- Any previously issued invoice can be viewed and or edited. Correcting errors, as well as deleting and undeleting invoices, is as simple as one can imagine. The complete invoicing history of a patient, including unique CPT4 and ICD9 codes used, can also be displayed by clicking a single button.
- MDRhythm has powerful payment posting and accounting features, which include editable entries and automatic supplementary billing. It provides real-time accounting, comprehensive post-payment functions, graphical ledger cards, activity reports, aging reports for both patients and insurance companies, invoiced procedure analysis, financial analysis reports, account summaries, batch invoicing contracted fees, allowable amounts and monthly statement capability.

- Statements can be printed on plain paper or sent electronically to our clearinghouse as a value added service.
- Each invoice is tracked individually instead of tracking only the account balance.
- As evidenced on the picture below (Figure 5), a complete audit trail can be maintained while simultaneously reducing the amount of time required for posting.
- Payments can be posted in two different ways; either posting against the total invoice amount, or posting against each procedure code to allow a complete audit trail. Any balance remaining on an invoice can be billed automatically to the patient, supplemental insurance, or can be written-off or adjusted.

- Approved amounts by Medicare can be entered to automatically calculate the amounts of payments received and adjustments.
- The Ledger/information screen (Figure 6) displays the patient demographics, the patient's ledger card, an account summary, and an aging report on the patient's account balance.
- The user can view a patient's treatment history with the click of the mouse. Also the system tracks each date of transmission or printing of invoices.
- The Accounting activities for the day (day sheet), week, month, quarter, or year separated by user or provider can be displayed and printed easily by clicking the desired buttons. The following picture of this screen shows a typical day sheet (Figure 7):

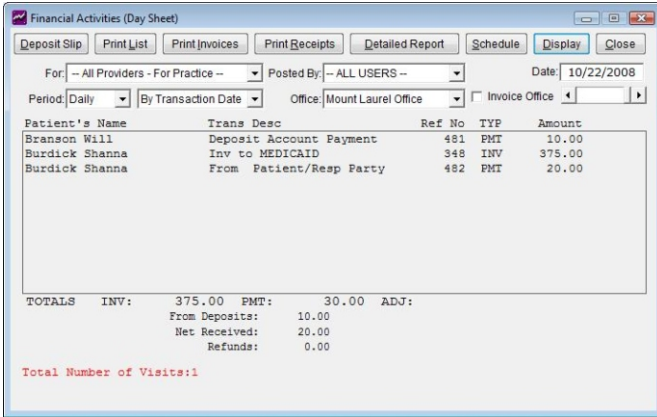

Daily/Weekly/Monthly/Yearly Accounting Information Screen

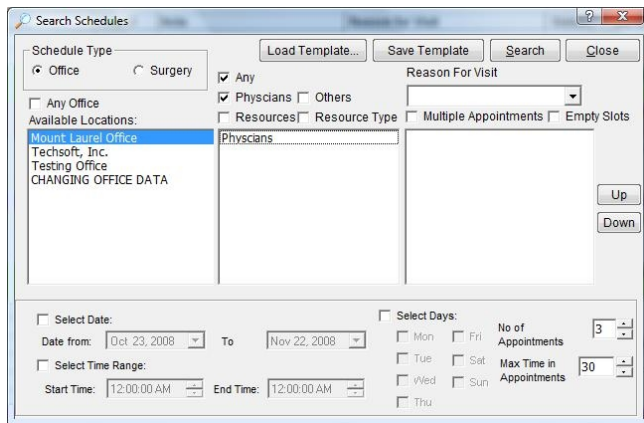


Figure 8 Schedule Search Results Screen

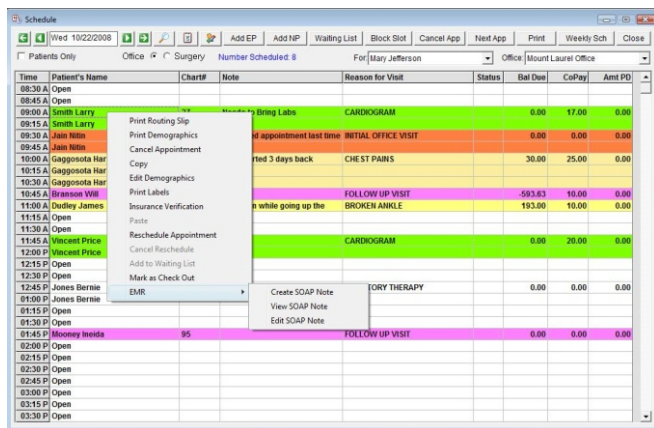


Figure - 9 Scheduling Screen

- MDRhythm provides detailed aging reports. Users can select an aging report that lists all overdue invoices by patient (all patients that have unpaid invoices for X number of days or more), or they can generate an aging report that lists all overdue invoices by insurance company (All insurance companies that have unpaid invoices for X number of days or more).
- The user can select any number of days for the aging report (30 days or older, 43 days or older, etc.).
- MDRhythm also provides a detailed Invoiced Procedure Analysis. With this function, any one or several CPT codes can be analyzed for frequency of use, and analyzed for the amounts billed and received.
- MDRhythm also provides a Financial Analysis, which presents a breakdown of all the procedures performed by each provider, and the amounts billed and received by each provider for each of those procedures.
- MDRhythm provides an advanced and powerful scheduling system. Creating, canceling or modifying patient appointments is extremely easy to accomplish.
- Our scheduling system includes the ability to schedule for multiple providers / resources and tracks patient waiting times.
- The Search feature is among the most advanced of it's kind. The user can search by office, resource, provider, or even day of the week and time restrictions. Figure 8 lists the search results screen of available appointments.
- The daily schedule screen (Figure 9) lists all the appointments for the day, shows the patient's name, chart number, home telephone number, reason for visit, a real-time status box (checked in, checked out, invoiced), balance due (patient's obligation) from previous visits, and patient co-pay and free text notes.
- As can be seen from the choices available in the above figure, all scheduling/billing functions can be performed without ever leaving the Daily Schedule screen.
- Users can add a new or existing patient to the appointment list for the current date, or any date in the future, with the click of a button. Instead of typing out the patient's name, users can select an existing patient from an alphabetical list, saving time.
- The patient's last date of visit and next appointment dates are displayed with click of a button. Time slots are variable and can be set to any length of time desired.

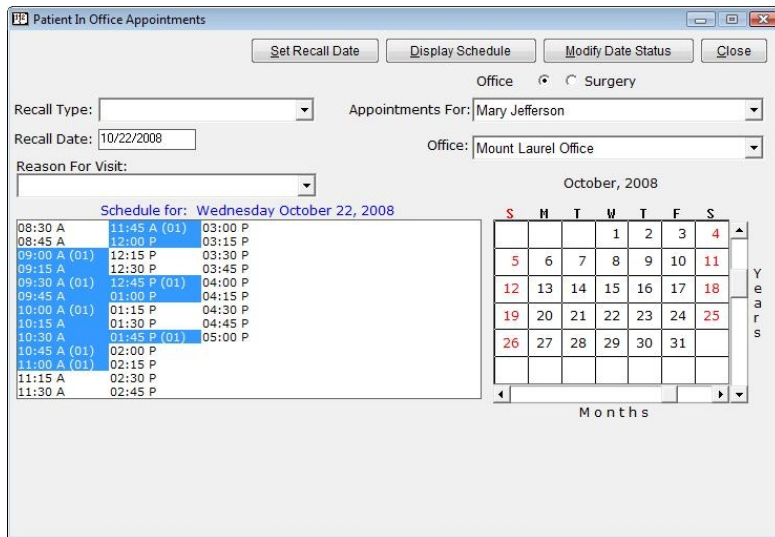
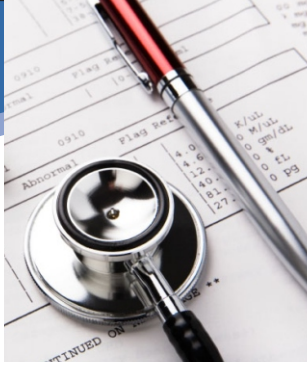


Figure 10 - Monthly Calendar Screen

- The time required for a visit is automatically set based upon the reason for visit. One can even restrict how many patients are allowed per time slot, per hour, per shift or even per provider.
- If desired, this software can track average waiting time and time spent with the provider. When a patient arrives for an appointment, users can check that patient in with a single mouse click.
- After the visit and/or examination, users can check that patient out with the click of a button. After the patient has left, users can be brought to the invoicing screen, complete with patient information, with the click of a button. Complete invoices can be generated instantaneously.
- MDRhythm allows each provider to design his or her own custom office hours and routing or fee slips.

- MDRhythm allows the user to create different schedule slot times for each provider and or resource. It provides an office schedule and surgery schedule that can be fully customized.
- Switching between office and surgery schedules is as easy as clicking a button. Single appointment times or entire dates on the calendar can be edited. Each provider can set the amount of time slotted for each visit on his or her schedule. (10 minutes, 15 minutes, 20 minutes, etc.)
- Switching between different provider's schedules is as easy as pointing and clicking on the provider's name. Also, any schedule for any date can be easily printed on demand. Special notes can be added for each patient for each scheduled visit.
- The MDRhythm Monthly calendar (Figure 10) gives users the opportunity to mark and edit special dates on the graphical monthly calendar.
- From this screen, all the daily schedules can be viewed, new and existing patients can be scheduled, and any appointment times can be marked for a provider-selectable activity. In addition recalls can be set for future time periods such as 6 months one year etc.
- Different reasons for recall can be added and custom letters can be created for easy printing of patient recall letters and or labels.
- A user can modify the date status of any one date without resetting the entire schedule. When patients are displaced due to shorter day or an off day, the system retains their schedule date and time and keeps the list handy till all the displaced patients have been re-scheduled.

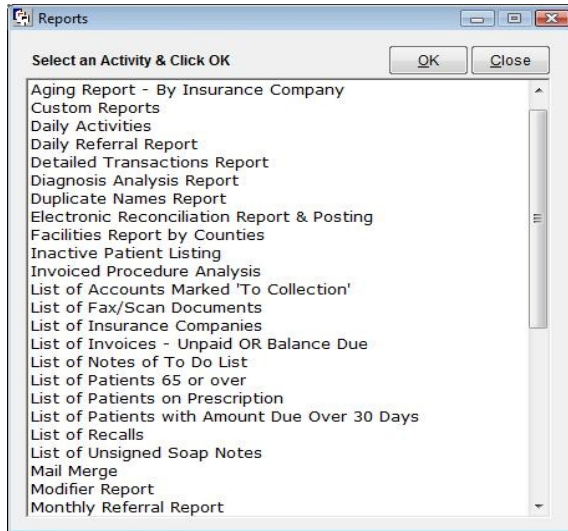


Figure - 11 List of Reports (Partial)

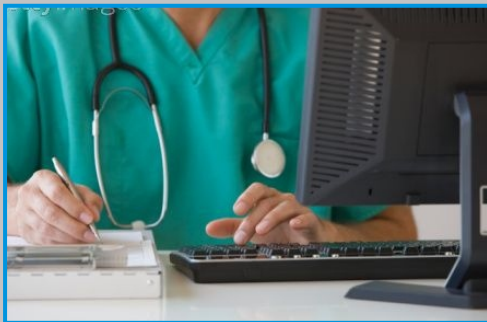
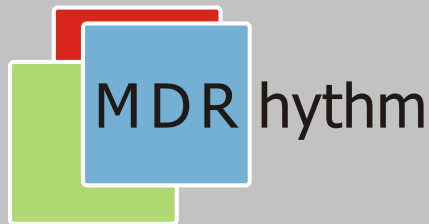
